





Summary:

The State Government has proposed a series of mergers involving the Holroyd Local Government Area including:

- a) Auburn City (part), Holroyd City (majority) and Parramatta City (part) Councils
- b) Parramatta City (part), Auburn City (part), Holroyd City (part), The Hills (part) and Hornsby Shire (part) Councils
- c) Burwood, City of Canada Bay and Strathfield Municipal Councils.

Council has prepared three (3) submissions in response to the relevant proposals affecting Holroyd.

Report:

The Premier of NSW and the Minister for Local Government announced on 18 December 2015 the next phase of the Fit for the Future Process for the reform of Local Government in NSW. On 6 January 2016, the State Government formally referred its proposed Council mergers to the Chief Executive Officer for the Office of Local Government. The Chief Executive Officer subsequently referred individual merger proposals to delegates for further examination and report.

The Holroyd Local Government Area is directly affected by two merger proposals, the Auburn City (part), Holroyd City (majority) and Parramatta City (part) Councils' proposal and the Parramatta City (part), Auburn City (part), Holroyd City (part), The Hills (part) and Hornsby Shire (part) Councils' proposal. It is also indirectly affected by the Burwood, City of Canada Bay and Strathfield Municipal Councils' proposal.

Delegates were required to hold public inquiries for each proposal. The public inquiry for the Auburn City (part), Holroyd City (majority) and Parramatta City (part)

Councils' proposal was held on 4 February 2016 and the public inquiry for the Parramatta City (part), Auburn City (part), Holroyd City (part), The Hills (part) and Hornsby Shire (part) Councils' proposal was held on 2 February 2016. The Delegates will continue to accept public submissions until 5.00 p.m. on 28 February 2016.

The submissions address the criteria as set out under Section 263 of the Local Government Act 1993.

Council's submission seeks a number of amendments to maximise the effectiveness of the new Council, should the merger proposal proceed, including:

- Logical boundary adjustments to better equip the new Council to succeed and address existing boundary anomalies.
- Ward and Councillor numbers that maximise the residents' ability to be represented.
- The reallocation of assets and liabilities between affected Councils be completed in consultation with an auditing firm agreed to by the Council.
- Staffing salaries and conditions are preserved in accordance with the existing Awards, the Local Government Act as it relates to no forced redundancies for a period of three years and local agreements and arrangements.

Council's draft submissions have been provided to Councillors under separate cover.

Conclusion:

The submissions to the Council Boundary Review have been prepared with consideration given to the feedback received from the Holroyd community throughout the Local Government reform process and seek to ensure the best possible outcome for the community should the merger proposal proceed. Submissions will close at 5:00 p.m. on 28 February 2016. The Delegates' Reports are expected to be completed by the end of March 2016.

Consultation:

Council has conducted a series of community engagement activities throughout the Fit for the Future process including a number of public workshops, public meetings and information sessions to fully engage the community on this topic.

Council has advertised the opportunity to make a public submission to the Council Boundary Review and promoted the public inquiries to encourage residents to attend or submit a response during the public submission period.

- iv) That Council authorise the Mayor and General Manager to make minor administrative amendments and refinements to the draft submission and approve to submit to the relevant Delegates responsible for the merger proposals that impact the Holroyd Local Government Area by 28 February 2016.
