

Min. 111 MAYORAL MINUTE: The Mayor, Clr. Cummings, here raised a Mayoral Minute in relation to a local sporting athlete, Ellie Carpenter.

The Mayoral Minute was moved by the Mayor, Clr. Cummings, seconded by Clr. Whitfield and resolved as follows:

"Tonight, I would like to make special mention of the amazing efforts of one of Holroyd's young sporting stars - Ellie Carpenter from Pemulwuy.

At just 15, Ellie is a key member of the victorious Matildas Women's National Football Team which recently qualified for the Rio Olympics.

The team secured their spot in Rio after achieving an unbeaten run in the Olympic qualifiers - recording three wins and a draw against a very strong Asian competition including Japan.

It was a gruelling schedule for the Matildas - playing 5 games in 10 days!

This was a remarkable achievement for all of the Matildas, but in particular, for local resident Ellie Carpenter.

Ellie became the first player born in the 2000s to play for a senior Australian football team - either the Matildas or the men's Socceroos.

Qualifying for the Olympics caps off an extraordinary season for Ellie.

Not only did Ellie play in every game for the Western Sydney Wanderers in her W-League debut season, but she was also named the Women's Game Best Newcomer of

the Year and also won the Parramatta Advertiser's Junior Sports Star of the Year Award.

Ellie's strength, determination and courage is a real inspiration to all our local youth and on behalf of Holroyd City Council I congratulate Ellie on her achievements and wish her the very best on her road to Rio."
